*Ladies and gentlemen,*

Turnover in 2025 of € 2 billion (+2 %) was helped by the encouraging development of the Autania machine tool group (+14 %).

The war in Ukraine, crises in the Middle East and Iran, as well as the weak economic situation in Europe, and particularly in Germany, all continued to have a negative impact.

Despite this uncertain backdrop, however, our group was able to rely on the flexibility and strength of our family-owned business, which, thanks to its financial strength, was able to maintain a very high level of delivery readiness by maintaining high inventory levels and to adapt to the changing market conditions through the application of strict cost control.

As a result of the significant increase in investment in the defense and energy sectors, our group received orders in the double-digit million range for machine tools as well as for the production of turbine blades. The turbine blade plant in Thailand, which was reopened on November 29, 2024 after a major fire, was achieved an increase in production output of more than 20 % in 2025 already thanks to its state-of-the-art facilities and machinery.

After more than four years of planning, approval, and construction, we celebrated the topping-out ceremony for the new logistics center of Nordwest Handel AG in Alsfeld on September 23, 2025. We plan to begin relocating from the current logistics site in Gießen to Alsfeld in March 2026, with full delivery readiness from Alsfeld to be achieved by March 2027.

Our high equity ratio of over 50 % together with a balance sheet total of € 1.6 billion forms the financial basis for a record investment volume of more than € 300 million over three years, with a view to achieving our sales target of € 3 billion in 2030.

Dr. Helmut Rothenberger Holding is ready and capable of meeting the challenges posed by an increasingly difficult market environment, shaped by political and economic uncertainties against a background of energy transition and climate change.

My thanks go to all dedicated employees, managers, business partners, and my family who have contributed to this very positive result.


